9M 2008 FINANCIAL RESULTS

NEGATIVE RESULTS DUE TO ADVERSE CONDITIONS WORDWIDE

ALPHA TRUST ANDROMEDA S.A. published its financial results for the nine month period of 2008 under the International Financial Reporting Standards.

The wider losses in the international markets as well as in the Athens Exchange amid the adverse conditions stemming from the world credit crisis have also affected ALPHA TRUST ANDROMEDA S.A. results. The company reported negative net after tax results amounting to € 31.07 million versus profits of € 14.97 million in the respective nine month term of 2007.

Andromeda's total assets at the end of the nine month period of 2008 stood at € 70.82 mil. decreased by 29.36% from the beginning of the year. Negative was the return of all other sector peers that ranged between -12.43% to -43.39%, according to data published by the Association of Greek Institutional Investors, with sector's weighted average return in the nine month period of 2008 forming at -25.38%. The return of all investment trust companies for the same period was better than that of ATHEX General Index that stood at -44.84%.

ANDROMEDA's Net Asset Value (NAV) on September 30, 2008 stood at € 2.51, while its share price stood at € 1.64, thus trading at a discount of - 34.66%.

Sector's weighted average NAV stood at -39.79% and all the ATHEX listed Investment Trust Companies were trading at a discount from -18.18% to -54.52%.
