PRESS RELEASE: 9M 2010 FINANCIAL RESULTS

ALPHA TRUST ANDROMEDA S.A. released its financial results for the nine month period of 2010 under the International Financial Reporting Standards.

Markets volatility sustained during the third quarter of the year as well. However, there was a moderate recoup in the international equity markets, which was followed only in part by the domestic market, a fact that was also evident at ALPHATRUST ANDROMEDA's nine-month financial results, which appear improved versus the six-month period of 2010. In the nine month period of 2010 the company marked losses after tax of the amount of € 4.400 mil. (in the first half of 2010 losses after tax amounted at €5.392 mil.) compared to earnings after tax amounting € 6.604 mil. in the nine month period of 2009.

Company's gross income from portfolio management stood at approximately € -2.96 mil., which break down to € 4.24 mil. from losses from securities transactions and € 1.28 mil. from portfolio revenues.

According to the data provided by the Association of Greek Institutional Investors, the returns of the sector companies ranged from -2.17% to -11.21% significantly better than the Athens Exchange General Index, that during the same period eased by -33.02%

ANDROMEDA'S Net Asset Value (NAV) at the end of the nine month period of 2010 stood at € 1.74, while its share price at € 0.94. Trading at a discount of -45.98%. All ATHEX listed Investment Trust Companies were trading at a discount ranging from -31.79% to -52.59% while the sector's weighted average NAV stood at -41.69%.

ANDROMEDA's total assets at the end of the nine month period of 2010 stood at € 47.90 mil. decreased by 8.32% as of the beginning of the year, while ANDROMEDA'S portfolio in current prices including own shares, was invested approximately by 67.67% in shares (out of which 42.99% in Greece and 24.68% abroad), 17.11% in bonds, 4.67% in cash reserves and 10.55% in funds abroad.

The geographical allocation of the Company's portfolio at the end of the nine month period stands at about 62.91% in Greece, 3.79% in Eurozone countries (excluding Greece), 2.01% in England, 19.61% in USA, 6.21% in Switzerland, 2.26% in Romania and 3.21% in Norway.

6M 2010 FINANCIAL RESULTS

ALPHA TRUST ANDROMEDA S.A. released its financial results for the first semester 2010 under the International Financial Reporting Standards.

The intense fiscal problems that the country is facing as well as the broader market instability on an international level have had an adverse impact on the Company's results during the first semester of 2010. During this period ANDROMEDA marked losses after tax of the amount of € 5.392 mil. compared to earnings after tax amounting € 1.365 mil. in the first semester of 2009.

Company's gross income from portfolio management for the first semester stood at approximately € -4.45 mil., which break down to € 5.34 mil. from losses from securities transactions and € 0.89 mil. from portfolio revenues.
